Bogatan Phudsil Rural Municipality Office **has received a grant** from **GoN** towards the cost of Construction of Primary Hospital (15-Bed) for Bogatan Phudsil Rural Municipality Doti and intends to apply part of the funds to cover eligible payments under the Contract. Bidding is open to all eligible as per Section V of bidding document..
2. Bogatan Phudsil Rural Municipality Office invites electronic bids from eligible bidders for the construction of Construction of Primary Hospital (15-Bed) for Bogatan Phudsil Rural Municipality Doti under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: [**Nrs. 20,90,00,000/- (Two Hundred Nine Million)]**
 - Minimum Work experience of similar size and nature: [**One (1) Contract of RCC Framed Building Construction Project within the last ten (10) years with a value of at least Nrs. 13,90,00,000/-(One Hundred Thirty Nine Million) Including VAT**]
 - Minimum Construction experience in Key Activities in a single Project: [**1. Structural Concrete M20 or more: 1013.00 Cum. 2. Reinforcement Works: 180.00 MT. 3. Brick Masonry Works: 428.00 Cum. 4. Ashlar Stone Masonry: 362.00 Cum.**]
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

7. Electronic bids must be submitted to the office BogatanPhudsil Rural Municipality Office Chawarachautara, Doti through PPMO website www.bolpatra.gov.np. on or before 12:00 Noon on 27-May-2021 (2078/02/13). Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 27-May-2021 (2078/02/13) at the office of Bogatan Phudsil Rural Municipality Office Chawarachautara, Doti. Bids must be valid for a period of 120 (One Hundred Twenty) Days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of 44,00,000/- (Fourty Four Lakh Only), which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. Bogatan Phudsil Rural Municipality Office, Chawarachautara, Doti reserve the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
