1. The Government of Nepal (GoN) has allocated funds to Bogtan phudsil Rural Municipality for **Trail Bridge Sector Wide Program** and the Municipality intends to apply part of the funds to cover eligible payments under the Contract for supply of fabricated steel parts for following Short Span Trail Bridges (SSTB). Bid is open to all eligible Nepalese Bidders.
2. The **Bogatan phudsil Rural Municipality Office, Doti** invites sealed bids from registered fabricators for supply of fabricated steel parts for following Short Span Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years and enlisted by DoLI are eligible for bidding. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLI may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.

Bidding documents may be purchased from the office of **Bogatan phudsil Municipality, Doti**, by eligible Bidders, on submission of a written application and upon payment of a non-refundable fee for bid documents as mentioned in the following table, until **2077/ 09 / 07**. For the purpose of Bidders who choose to submit their bid part of bidding documents, prepare their bids and submit their electronic bids as specified in the Instructions to Bidders. In case the Bidder chooses, the Bidder shall be required to deposit the cost of bidding document (as specified in the below table) in the Rural Municipality's (**Rajashawo Kos Kosh AC NO D704010000007, Dharauti D704010000004**) either by direct deposit or by tele-transfer of deposit in the Rural Municipality account for the purchase the bids as specified below and electronic scanned copy (PDF format) of the Bank deposit voucher or Tele-transfer certificate shall also be submitted along with the electronic bid files.

Bids will be opened physically and electronically in the presence of Bidders' representatives who choose to attend at **14:00 hours** on **2077/ 09 / 21** at the office of **Bogkatan Fudsil Rural Municipality, Doti**. Bids must be valid accompanied by bid security, amounting to a **minimum of amount (inclusive of VAT)** listed below, which shall be **valid upto / 90 / Days**.

If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in Deposit Account No. (Rajashawo Kos Kosh AC NO D704010000007, Dharauti D704010000004 of Bogatan Phudsil Rural Municipality Office, Doti in Global IME Bank Chawarachatura, Doti and submit bank deposit voucher along with the bid.
